**How to return your ballot**

**Return to local clerk's office by 8 p.m. on Election Day**  
Drop off your ballot at your local clerk's office or drop box (if available)  
— no postage required.

**Return by Mail**  
Mail your ballot so it is received by 8 p.m. on Election Day  
— postage required.

If you make a mistake on your ballot, contact your local clerk for a new ballot.

You will receive this **BLUE ENVELOPE** containing your ballot starting with the March 2020 Presidential Primary Election.

I assert that:

- I am returning my ballot to the clerk's office by delivering it myself or a member of my immediate family or household, or sending it by public postal, express mail, or registered mail, or other means of carrier.

I understand that knowingly making a false statement is a misdemeanor.

**VOTER SIGNATURE REQUIRED**

**VOTER sign here in ink. Power of attorney is not acceptable.**

**Keep your ballot secure.**  
It is a felony for anyone to be in possession of an absent voter ballot except authorized election officials, employees of postal services or other common carriers during the normal course of their job handling mail, or a member of the voter's immediate family or household who the absent voter has asked to return the ballot.

A person who assists an absent voter and who knowingly makes a false statement is guilty of a felony.

**SIGN HERE!**

You will return your ballot to the Clerk's Office in the **GREEN ENVELOPE** in one of the following ways: returning your ballot by mail, dropping it off at the Clerk's Office, or placing it in the locked drop box located in the lobby or at the door for after hours. Make sure you **SIGN** the back of the **GREEN ENVELOPE** before returning to the Clerk's Office!
